Applications received will be kept on file in order of date received and acted upon during the open membership period. If membership is at capacity application will be kept on file in order of date received until such time that membership falls below the CSC membership cap.

Coopersville Sportsman Club uses club fund raising events and raffles to generate ALL income.

We opt for this method rather than expensive membership dues. So we ask and require member participation in club events, work bees and the selling of raffle tickets.

Prospective applicants who are accepted are <u>required</u> to work 10 hours at club events and work 10 hours at or on club grounds per membership year.

Coopersville Sportsman Club holds monthly gun raffles – tickets are \$5.00 each. There are 11 monthly drawings for either a gun or a gift certificate and 1 drawing for Summerfest where we give multiple (6-8) prizes on the same ticket; also \$5.00 each. We ask, but do not require, that new members try and sell a number of tickets for the 11 monthly drawings; it may be as low as 1 ticket for each drawing. For the Summerfest drawing <u>ALL</u> members receive a packet of 20 tickets; we ask members to sell as many as possible.

Members, including spouse and children 17 years of age and younger, are allowed full use of Coopersville Sportsman Club its grounds, ranges and buildings for general use. To reserve the grounds, ranges and buildings for a function member must make a request at a regular scheduled membership meeting.

Members of Coopersville Sportsman Club must follow all local, state, federal and provincial game laws at all times.

Coopersville Sportsman Club is a private non-profit organization which reserves the right to deny membership to any individual who does not meet the terms and conditions of this application. Coopersville Sportsman Club also reserves the right to deny membership to any individual who is not consistent with the clubs' mission statement.
